Test Procedure测试程序:

1. Tests T.1 to T.5 are conducted in sequence on the same battery, Tests 6 and 8 are conducted using not otherwise tested batteries. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1 to T.5 for purposes of testing on cycled batteries.

2. In order to quantify the mass loss, the following procedure is provided:

$$\text{Mass loss}(\%) = (M_1 - M_2) / M_1 \times 100$$

Where M_1 is the mass before the test and M_2 is the mass after the test. When mass loss does not exceed the values in Table below, it is considered as "no mass loss".

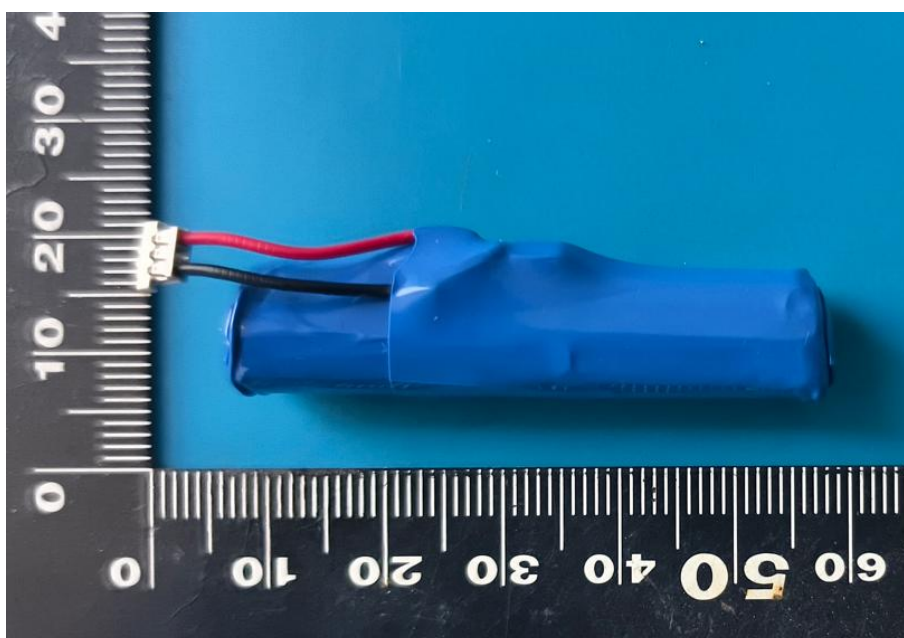


Fig. 3 – Front view of Cell
